

Highlights of the new plan options

- You can see your current providers as long as they are a Medicare provider accepting the plan. In fact, 99.9% of UnitedHealthcare Medicare Advantage members continue to have access to their chosen providers.
- The plan options provide features that are not commonly available through individual plans. These plan features include no limits on skilled nursing facility benefits, no lifetime maximum for inpatient hospitalization, a dedicated UnitedHealthcare team supporting IBM retirees, and more.
- Both plan options have a large drug list, uniquely designed for IBM, which will cover nearly all Medicare Part D medications. A complete drug list will be coming soon.

It's your choice – consider your alternatives now!

Transition to the new Group Medicare Advantage plan options, which are designed exclusively for IBM retiree benefit participants eligible for Medicare. There are two options under the IBM retiree medical plan – the Enhanced Plan and the Essential Plan. While you do have a choice, based on UnitedHealthcare's experience, the Enhanced Plan is the best option for the majority of participants. Keep in mind that the IBM subsidy is only available when you enroll in one of the new UnitedHealthcare plan options.

OR

Remain enrolled in the coverage you have today — If you would like to remain enrolled in your current plans, including those through Via Benefits, you can do so. Please be aware that, if you choose to remain in your current plans, you will no longer be eligible for IBM's subsidy while enrolled there. IBM is only able to assist with Via Benefits administration issues through the end of the 2022 plan year. Special rules apply for those currently enrolled in Kaiser, Medicaid, TRICARE, VA Benefits, and those living abroad. Call UnitedHealthcare for details.

What to expect from UnitedHealthcare*

Anyone who is currently receiving IBM retiree medical benefits and is eligible for Medicare will receive more information as outlined below.

September 14	Enrollment period begins. Contact the IBM Retiree Call Center, administered by UnitedHealthcare, to enroll.
Late September	An Educational Brochure, mailed to your home that explains the features of the new plan options, plan costs and how the IBM subsidy works, along with a handy worksheet to complete prior to contacting the IBM Retiree Call Center.
Early October	 A Plan Guide, mailed to your home that includes: A side-by-side comparison of the two Group Medicare Advantage plan options, A summary of medical and prescription drug coverage, Information on the enrollment process, and more.
October 17 - November 4	Virtual Retiree Meetings. You'll receive additional details regarding the meeting dates and how to participate included with the Educational Brochure and on the IBM Retiree Medical Website.
December 16	Enrollment period ends
January 1, 2023	Your elections take effect

What you need to do



Watch your mailbox for additional details regarding your plan options available through UnitedHealthcare. Medicare enrollment is a busy time and you will get lots of mail.



To enroll in one of the new IBM plan options, you must contact the IBM Retiree Call Center, which is open **now**. Knowledgeable UnitedHealthcare Customer Service Advocates are ready and waiting to assist you with enrollment and answer any questions you may have.



During the enrollment period, you will also have an opportunity to attend a virtual meeting to learn about your options. A pre-recorded version will also be available. The meeting schedule is included with the Educational Brochure and on the IBM Retiree Medical Website.

The deadline to enroll is December 16, 2022. If you do not take action, you will not be enrolled in the IBM plan, and will not receive any IBM subsidy for 2023. If you have a dependent who is eligible for Medicare under this plan, they must make their own independent election by calling the IBM Retiree Call Center.
